From West Lawrence (Plaza 202)

- Stay on McDonald Drive 0.8 miles to Rockledge Road (After passing the stop light at 2nd Street get in the right hand lane).
- **Turn right** onto Rockledge Road and follow it 0.3 miles to 6th Street/US-40.
- **Turn right** onto 6th Street/US-40 and travel 3.7 miles to Hwy. K-10 West.
- **Turn right** onto Hwy. K-10 West and follow it 2.1 miles to the “T” intersection.
- **Turn right** onto Douglas County Road 438/North 1800 Road/Farmer’s Turnpike/Lakeview Road and follow it approximately 5.0 miles to the industrial park complex.

From South Lecompton (Plaza 197-S)

- Travel approx. 0.1 mile to K-10.
- **Turn left** onto K-10 and follow it until you have to stop at a “T” intersection.
- **Turn right** onto Douglas County Road 438/North 1800 Road/Farmer’s Turnpike/Lakeview Road and follow it approximately 5.0 miles to the industrial park complex.

From North Lecompton (Plaza 197-N)

- Travel approx. 0.1 mile to stop sign, which is K-10 intersection.
- **Turn right** onto K-10 and follow it 0.2 mile until you have to stop at a "T" intersection.
- **Turn right** onto Douglas County Road 438/North 1800 Road/Farmer's Turnpike/Lakeview Road and follow it approximately 5.0 miles to the industrial park complex.

From East Lawrence (Plaza 204)

- Travel 0.1 mile to stop light, which is N. 3rd Street.
- **Turn left** onto 3rd Street/US-59/US-40 and follow it 1.3 miles south to 6th Street.
- **Turn right** on 6th Street and follow it 5.5 miles to K-10.
- **Turn right** on K-10 and follow it 2.1 miles until you have to stop at a "T" intersection.
- **Turn right** onto Douglas County Road 438/North 1800 Road/Farmer's Turnpike/Lakeview Road and follow it approximately 5.0 miles to the industrial park complex.
