You must establish a credit account to cover toll charges. A \$5 fee per tag is added to the first bill and thereafter on an annual basis.

**K-TAG III** Purchase Program: This program is good if you can't justify a recurring account fee. Complete section **B** and sign below. You buy a tag (\$12.50 each) but pay no monthly or annual fees. Tolls are charged monthly to the payment card you supply. Shipping & handling charges apply.

## K-TAG AGREEMENT

You accept responsibility for all tags delivered as a result of this application and agree that all charges made by the use of these tags will be your responsibility. Payment is due by the end of the month following charges. If payment is not received by the end of the month following charges, your tags may be invalidated. You agree to be liable for the use of all tags issued to your account until you notify the KTA at 1-800-873-5824 or [ktag@ksturnpike.com](mailto:ktag@ksturnpike.com), of loss, theft, or unauthorized use.

You understand that you are subject to all state laws and the rules of the KTA as outlined in the Customer Agreement. You agree that you will read, and be bound by the terms set forth in the Starter Kit. You understand that if you do not agree with KTA policies as outlined in the Customer Agreement, you may return your unused K-TAG within 30 days for a refund. The Customer Agreement will accompany your K-TAG sticker or can be found online at <http://www.myktag.com>. You understand that if you have an external or first-generation tag (non-sticker tag), you must return it upon closure of your account or upon request from the KTA or your account will be charged \$34.00 per tag.

If you have circled a credit card payment option, you agree to provide and maintain a valid payment card. You authorize the KTA to charge your payment card for the amounts necessary to satisfy your obligations under this agreement until you notify KTA that you wish to stop the recurring billing, change payment cards or close your account. In some cases, credit approval will be required for your account to remain open in the absence of a valid payment card. Lack of a valid payment card may cause you to be moved into a different K-TAG program which could result in additional fees.

KTA has the right to investigate the credit of each applicant prior to extension of credit, credit renewal and update of records. Upon request you will be given the name and address of the credit bureau supplying the report. Also, your signature(s) on the application will authorize direct release of credit or banking experience to KTA upon their request from any of the references listed. KTA may also report its credit experience with you to any credit bureau.
